Item 1 – Introduction: Is an investment advisory account right for you?

MacNicol & Associates Asset Management US, LLC is registered with the Securities and Exchange Commission as an investment adviser. Please be aware that brokerage and investment advisory services and fees differ and it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

Item 2 – What investment services and advice can you provide me?

We offer investment advisory services to retail investors. Our principal service is portfolio management. As part of our standard wealth management service we provide continuous and regular supervisory and/or management services with respect to your account(s). As part of our portfolio management service, we may use the services of a sub-advisor to manage portions of your account. Our portfolio management services are offered on either a *discretionary* or *non-discretionary* basis. *Discretionary* authorization allows us to determine the specific securities, and the amount of securities, to be purchased or sold for your account without your approval prior to each transaction. *Non-discretionary* arrangements require us to obtain your approval prior to executing any transactions on behalf of your account. We do not limit our advice to proprietary products, or a limited menu of products or types of investments. In general, we require a minimum of \$1,000,000 to establish a relationship with us. At our discretion, we reserve the right to waive this minimum.

Item 3 – What fees will I pay?

We are primarily compensated by a percentage of assets under our management. Our fees are payable quarterly in arrears and are based on the value of assets on the last day of the calendar quarter. Our fees are not negotiable. Fees will be prorated for the first partial quarter and adjusted for any deposits during the quarter. The more assets there are in your advisory account, the more you will pay in fees. Therefore, we have an incentive to encourage you to increase the assets in your account. The fee paid by the client along with the terms of our relationship with clients is clearly listed in the advisory agreement signed by our firm and the client.

Description of Other Fees and Costs: The fees that you pay to our firm for investment advisory services are separate and distinct from the fees and expenses charged by investment companies (e.g., mutual funds, exchange traded funds, and unit investment trusts). These fees are described in each fund's prospectus. These fees will generally include a management fee and other fund expenses. You will also incur transaction charges and/or brokerage fees when purchasing or selling securities. These charges and fees are typically imposed by the broker-dealer or custodian that executes the trade. The broker-dealer or custodian may also charge your account for custodial fees, retirement account fees, trust fees, exchange fees, redemption fees that may be assessed on investment company shares, transfer fees, account termination fees or other special service fees and charges. We do not share in any portion of these fees imposed by the broker-dealer or custodian. To fully understand the total cost you will incur, you should review all the fees charged by investment companies, broker-dealers, our firm, and others.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Our primary source of compensation is through asset based fees. Therefore, we are incentivized to acquire new clients and to increase assets under management. We are affiliated with MacNicol & Associates Asset Management Inc., a Canadian investment adviser through common ownership and control and we may provide advisory services to one or more common clients. Due to the affiliation of the two entities, we have an incentive to recommend the services of our affiliate over the services of nonaffiliated firms. As such, clients are hereby informed that a conflict of interest is inherent in such an arrangement.

MacNicol & Associates Asset Management Inc. is the Trustee and Manager of The MacNicol Alternative Asset Trust that we may recommend to you. If you invest in this proprietary private fund, we will receive management fees and our affiliate will receive performance-based fees from the fund. This creates a conflict of interest because we have an incentive to recommend the fund over other investments. While our firm is accountable to you and the fund as a fiduciary and, consequently, must exercise good faith and integrity in handling both your and the fund's business, you should be aware of the existence of this conflict of interest. Investors in the fund should refer to the offering documents of the fund for detailed disclosures.

MacNicol & Associates upholds its fiduciary duty and only recommends advisers that it believes will act in the client's best interest. Other conflicts of interest result from other business activities we engage in and relationships we have with business partners, third parties, or other financial institutions.

Therefore, our financial professionals have an incentive to encourage you to increase the assets in your account and to increase our firm's profits.
